



American Society of Military Comptrollers (ASMC) Southern Maryland Chapter Scholarship Application



Objective

To recognize outstanding high school seniors in the Southern Maryland/Tri-County area (to include St. Mary's, Charles, and Calvert) and provide financial assistance to continue their educational endeavors and encourage students to obtain a college education in the business/financial fields.

Award Criteria

- Applicant must be an outstanding high school student in one of the following Southern Maryland counties: St. Mary's, Calvert, or Charles
- Applicant must be in the final half of his/her senior year (12th grade)
- Applicant must be entering a field of study directly related to business or financial management, business administration, economics, public administration, accounting, or related area of study. **Applicants that do not declare a major within these fields will not be considered.**
- Applicant must be in good standing within their school environment.
- Applicant must have letter of acceptance or intention from a perspective college they have applied to.
- Applicant must have at least three (3) letters of recommendation. Two (2) must be from faculty members at their school, one of which must be from their principal, academic dean, or guidance counselor. Applicant may submit any other personal information or recommendations they feel will be applicable to judging criteria.
- Applicant must agree to participate in a brief interview with ASMC Scholarship Committee (if asked).
- If selected, applicant agrees to participate in the ASMC National Scholarship program, which provides the recipient the opportunity to receive additional scholarships at the National level. Currently, the National ASMC grants the following scholarships: **One** (1) for \$3,000; **Five** (5) for \$2,000; & **Five** (5) for \$1,000.

Submissions Requirements and Deadline

Only applications postmarked by April 14, 2017 will be considered. No other exceptions will be allowed. Absolutely no applications will be accepted by fax or email transmission. The award recipients will be **notified by May 5, 2017**. The winning recipient(s) will be invited to attend the ASMC award luncheon (in May 2017) for presentations of funds. The applicant will also be submitted to the National ASMC Scholarship Committee for consideration for their scholarships (see Award Criteria above – last bullet item).

Award Recognition

ASMC Southern Maryland Chapter will award at least (1) **\$500.00** scholarship to applicant(s) from the local Southern Maryland area assuming receipt of valid applications. It is at the discretion of the Scholarship Committee to award more than one, but no more than three (3) scholarships per year.
